<b>Objectives of the Course</b>	The main aim of this course for third year students is to help them in gaining knowledge about the historical development and characteristics of the attorney profession; rights, obligations and responsibilities of attorneys, to inform them about attorney contract and attorney fee and to provide them with the skills to use this theoretical knowledge in practice.
