Objectives of the Course	This course deals with the ideal of equality, which is important for actors in all areas of social life, but is of particular importance for students who will practice law professions, together with concepts such as non-discrimination, respect for differences, coexistence, power, majority, minority, inclusiveness, etc. The course aims both to provide students with a theoretical grounding and to compare them with the social manifestations of these issues on a global and national scale.
Short Course Content	The course will provide a theoretical and analytical ground for the concept of equality by referring to the main philosophical and historical conceptualizations of the concept of equality. Subsequently, other facts and concepts that should be considered together with the concept will be discussed. Once the necessary theoretical ground has been acquired, these concepts will be concretized through social phenomena and events that are also within the scope of the protection of the law, and it will be aimed to produce critical knowledge through the students' observation skills and critical understanding of these phenomena.
